4. The organization did not engage or retain an advertising firm or consultant that had also been engaged or retained within the prior 6 months by the candidate, candidate's committee, or ballot issue committee that is benefited by the independent expenditure.
5. The communication which is the subject of this statement complies with the attribution requirements of Iowa Code section 68A.405.
6. The organization is not a foreign national and no foreign national provided funding for this expenditure. A "foreign national" means a person who is not a citizen of the United States and who is not lawfully admitted for permanent residence. "Foreign national" includes a foreign principal, such as a government of a foreign country or a foreign political party, partnership, association, corporation, organization, or other combination of persons that has its primary place of business in or is organized under the laws of a foreign country.
