RE: Clarification for the file

Last year, Mr. Brooke closed his campaign committee and transferred the campaign account to a different account, then filed another DR-1. There was no activity during this year and he paid a final bill and gave the balance to a non-profit charity. Since the final bill was just over \$100 (under the \$750 per calendar year filing threshold) I marked his committee as voluntary, not required to file.

I then scanned in the DR-2 and expenditure page and put them as an addendum to the previous report to show where the final money was expended.
