ONE-TIME CONTRIBUTION IN EXCESS OF \$750
BY A PERMANENT ORGANIZATION

Iowa Code section 68A.402(9) requires a permanent organization that contributes in excess of \$750 to register and file reports as a PAC. This form is intended to serve those purposes. The form must be filed with the Board on or before the tenth day of the date the check was issued.

ORGANIZATION MAKING CONTRIBUTION:

Form for Organization Making Contribution with fields for Name (WARREN FAMILY FARMS, INC.), Mailing Address (P.O. Box 492, ALTOONA, IA 50005), and Email Address (Optional).

CONTACT PERSON FOR THE ORGANIZATION:

Form for Contact Person for the Organization with fields for Name (TERRY WARREN), Mailing Address (P.O. Box 492, ALTOONA, IA 50005), and Email Address (Optional).

CANDIDATE OR COMMITTEE RECEIVING THE CONTRIBUTION:

Form for Candidate or Committee Receiving the Contribution with fields for Name (ITS FOR THE KIDS COMMITTEE), Mailing Address (8409 NE 54th AVE ALTOONA, IA 50005), and Email Address (if available).

Form for Contribution Details with fields for Date of Contribution (7-19-06), Amount (\$1,000.00), Date of Election (2-28-06), and County (POLK).

If contribution to candidate, disclose source of original funds used to make such contribution (attach additional pages if necessary).

Criteria to use this form:

- 1. One campaign contribution in excess of \$750 was made to a state or local candidate, party, political committee (PAC) for either a candidate or a ballot issue, or any other organization that advocates the election or defeat of a candidate or ballot issue.
2. Must be a permanent organization not established for election purposes.
3. No person gave money to the organization for the purpose of the organization then using the money to make the contribution.
4. If the contribution was made to a candidate, no funds from a corporation or other prohibited contributor under Iowa Code section 68A.603 were used to make the contribution (this does not apply to a contribution made to a ballot issue committee).
5. Only one contribution to any campaign committee except for a ballot issue committee was made in a calendar year. No more than one contribution may be made to any one ballot issue committee during a ballot issue election. If more than one contribution and the total amount of the contributions exceed \$750, the organization must register with the Board as a political committee (PAC) within 10 days of crossing the \$750 threshold.

Statement of Affirmation:

I, Terry Warren, affirm that the contribution reported above is accurate. I further affirm that the information concerning the organization is correct and true to the best of my knowledge. I understand that by filing this form, I am subject to the laws found in Iowa Code chapter 68A and administrative rules found in chapter 381. I also understand that the failure to timely file this form leads to the imposition of civil penalties and the intentional failure to file the form may lead to additional civil and criminal sanctions.
