The above named committee and candidate have failed to file a reconciled bank statement that includes activity through December 31, 2005 with the January 19, 2006, campaign disclosure report in violation of Board rule 351 IAC 4.21 despite notice from the Iowa Ethics and Campaign Disclosure Board to do so. In recognition of the limited campaign activity of the committee, in lieu of holding a hearing the Board ordered administrative resolution of this matter.

In addition to the sanctions that were imposed, the Board directed the committee to be administratively dissolved.

The committee is relieved of further obligations to file campaign disclosure reports under Iowa Code section 68A.402. The committee shall maintain its campaign records for 3 years after the date of dissolution pursuant to Iowa Code section 68A.203.

IT SO ORDERED, that on November 3, 2006, the Iowa Ethics and Campaign Disclosure Board now considers the Pat Cline for State Representative committee closed and dissolved.
