The hearing is scheduled for 11:00 a.m. on February 8, 2007, and shall be held telephonically. By February 5, 2007, Respondent shall provide the Board's Legal Counsel with Respondent's appropriate telephone number.

**ALLEGATION**

1. Respondent is the "chair" for the Civil Services Political Education League "political committee."
2. Pursuant to Iowa Code sections 68A.402 and 68B.32A(7), Respondent was required to file an October 19, 2006 campaign disclosure report and has failed to do so.
3. If the conduct described in paragraph #2 is proven by a preponderance of the evidence, the Respondent is subject to the imposition of penalties under Iowa Code section 68B.32D.

Both parties may present evidence, call witnesses, and enter motions. The Board's Legal Counsel is responsible for proving the allegation. Copies of all filings should be addressed to the Board's Legal Counsel:



The procedure for settlement of this matter is governed by rule 351-9.5.
