Campaign Disclosure Notice: "Pursuant to 4.41(2) of the Iowa Ethics and Campaign Disclosure Procedures, the Campaign to Elect Hildebrand wishes to note that it inadvertently failed to include in the campaign advertisement that appeared in the November 2005 issue of the Pleasant Hill Edge publication the statement noting who paid for the advertisement. The advertisement was paid for by the Campaign to Elect Hildebrand. Additionally, the Campaign to Elect Hildebrand was mistakenly referred to as the Committee to Elect Hildebrand on all campaign literature. The Campaign to Elect Hildebrand believed that "Campaign" and "Committee" were synonymous, however it found out after the campaign was over that the two are not. Therefore, pursuant to rule 351-4.38(68A, 68B) we are disclosing these errors."
